E-BUSINESS/E-COMMERCE SUPPORT SCHEME  
MINIMUM TERMS & CONDITIONS

1. This package is confined to qualifying micro enterprises (employing at least one person full time basis and not more than ten employees)
2. Financial support shall not be provided retrospectively and expenditure incurred prior to date of approval is ineligible for grant aid.
3. All expenditure shall be net of VAT
4. The grant offer is conditional on the applicant supplying a current tax reference number and meeting the requirements of circular F49/13/87 as it applies to the tax affairs of recipients of state grants.
5. Payment of grant will be made on the basis of vouched expenditure, duly receipted when all works are completed.
6. Consultants utilised must be fully engaged in specified business.
7. Purchase of hardware is specifically excluded from this scheme.
8. Only third party costs qualify (i.e. cost of work you have commissioned others to do)
9. Eligible cost include travel and subsistence, trade fair attendance/exhibiting and the creation of marketing material specifically for overseas markets but excluding printing costs.
10. Funds are limited and will be allocated on a first come basis.
11. All claims for payment must be accompanied by original invoices and proof of payment.
12. Professional services do not qualify for assistance under this programme.
13. Clare County Enterprise Board reserves the right to terminate this scheme at any time.
